STATE OF WISCONSIN BROKER DISCLOSURE

to Non-Residential Customers

Wisconsin Law requires all real estate licensees to give the following information about brokerage services to prospective customer

BROKER DISCLOSURE TO CUSTOMERS

- + The duty to disclose to you in writing certain material adverse facts about a property, unless disclosure of the information is prohibited by law (see "Definition of Material Adverse Facts" below).
- + The duty to protect your confidentiality. Unless the law requires it, the broker will not disclose your confidential information of other parties.
- + The duty to safeguard trust funds and other property the broker holds
- + The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.
