

STATE OF WISCONSIN BROKER DISCLOSURE to Non-Residential Customers

Wisconsin Law requires all real estate licensees to give the following information about brokerage services to prospective customer

+ The duty to safeguard trust funds and other property the broker holds.

+ The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.
